**Grant Track Definitions:**

- **Demonstration:** Funding under this track helps state and local governments and federally recognized Indian tribes plan and implement programs and strategies to reduce recidivism and ensure safe and successful reentry of adults released from prisons and jails back to the community.
- **Mentoring:** Funding under this track helps nonprofit organizations and federally recognized Indian tribes implement mentoring projects to promote the safe and successful reintegration into the community of adults who have been incarcerated.
- **Substance Abuse:** Funding under this track helps state and local governments and federally recognized Indian tribes establish or enhance residential substance abuse treatment programs in correctional facilities that include aftercare and recovery supportive services.
- **Reentry Court:** Funding under this track helps state and local government agencies and federally recognized Indian tribes establish state, local, and tribal reentry courts to monitor offenders and provide them with the treatment services necessary to establish a self-sustaining and law-abiding life.
- **Family:** Funding under this track helps state and local governments and federally recognized Indian tribes to establish or enhance residential substance abuse treatment programs in correctional facilities including family supportive services.
- **Career:** Funding under this track helps states and local governments and federally recognized Indian tribes establish programs to train individuals in prisons, jails, or juvenile residential facilities for technology-based jobs and careers during the three-year period before their release.
